Peninsula Community Legal Centre is pleased to announce that it is providing free legal advice and ongoing assistance at City Life Inc. in the centre of Frankston.

The service operates every second Friday at City Life in Clyde Street, Frankston, for a period of four hours, coinciding with the hours of operation of the City Life Café, which offers a free lunch for vulnerable and disadvantaged members of the Frankston community, many of whom are homeless.

Helen Constas, Chief Executive Officer, says, "Peninsula Community Legal Centre welcomes the opportunity to work in partnership with City Life Inc. to ensure that services are available to those in need when they are in need. We are keen to ensure that all members of the community are aware of the services provided by us and where they can utilize these services.

Individual legal advice and assistance in areas such as debt, crime, family law and fines, as well as information in relation to the rights and responsibilities of rooming house and caravan park residents is available to those who attend. This outreach service increases the accessibility of legal and related services to the Frankston community."

A Lawyer and a community worker from the Legal Centre attend at City Life from 10.00am, and people who require assistance are encouraged to drop in at City Life at this time to make a time to see the lawyer during the day.

Ms Constas says, "Organisations like ours need to be proactive in identifying need and ensuring that services are located as close as possible to those requiring the use of the services. We are very pleased to be delivering this initiative."

Peninsula Community Legal Centre is a not-for-profit organisation that has been providing free legal services to its community for over 30 years.
