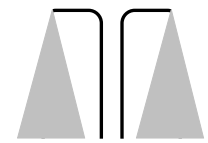

CEO, Helen Constatas also spoke at the breakfast and referred to recent Victoria Police statistics, which show that Frankston remains in the top 3 local government areas within Victoria for family violence incidences. "Over the past 5 years, Peninsula Community Legal Centre has had an overwhelming 233% increase in demand for assistance for family violence related matters at the Frankston Magistrates' Court. Interestingly, Victoria Police statistics indicate there has been a significant drop in crime in Frankston over the last year."
