## PCLC WANTS MEN TO SWEAR ON WHITE RIBBON DAY

PCLC and White Ribbon Foundation are calling on all Australian men to sign up and 'swear' to end violence against women, as the first step in creating culture change around the issue.

November 25 is International Day for the Elimination of Violence Against Women – White Ribbon Day.

The White Ribbon Foundation aims to engage men in the campaign to end violence against women through the creation of respectful relationships with women. White Ribbon focuses on the positive roles that men can play to create a culture where violence, and attitudes that support the use of violence, are increasingly unacceptable.

Brendan Stackpole, Solicitor in charge of the Family Law Program at Peninsula Community Legal Centre, has taken up the challenge of becoming a White Ribbon Ambassador and is encouraging all men to challenge violence-supporting attitudes and behaviours.

"You only need to look to the statistics to see the prevalence of violence towards women in our society. One in three women will experience physical violence and one in five women will experience sexual violence over their lifetime. This is because as a society we tolerate disrespectful attitudes towards women, which lead to these behaviours", says Brendan.

"I have sworn never to commit, excuse, or stay silent about violence against women and I am asking all men to sign up and 'swear' on November 25 to end violence against women. This is the first step in creating culture change around the issue of violence towards women.

"White Ribbon Day gives us all an opportunity to reflect on our own attitudes and behaviours and to promote equal and respectful relationships and non-violent social norms".

"Family violence provisions in the *Crimes (Family Violence)* Act, have been broadened to include other that physical or sexual abuse, behaviour that is emotionally or psychologically abusive, economically abusive, threatening, coercive or in other ways controlling or dominating".
