# Service Information

## Do you have a legal problem?

Peninsula Community Legal Centre can help. Each year we provide free legal advice and assistance to thousands of people in Melbourne's south east. We also provide information and education about the law.

Our Centre is an independent, not-for-profit organisation that has been providing free legal services since 1977. We pride ourselves on providing high quality services that are accessible and responsive to the needs of our community.

Free legal services are provided by staff and volunteers who are qualified lawyers or trained advocates working under the supervision of our principal lawyer.

## Can we help you?

You may be eligible for free legal advice if you live, work or study in our catchment area. For most legal issues, that includes the local government areas of Frankston, Mornington Peninsula, Casey, Cardinia, Kingston and Glen Eira.

Our Tenancy Assistance and Advocacy Program assist clients across a larger catchment area: Southern Metropolitan and Eastern Metropolitan Regions.

We may also be able to refer you to other services that can help you.

## What do you need help with?

Free legal advice is available to most people, but ongoing assistance is subject to guidelines that prioritise clients experiencing disadvantage.

We are able to help with most areas of law and commonly assist clients with family law, family violence, tenancy, fines, neighbour issues, motor vehicle accidents and debt-related issues. We cannot assist with business law or conveyancing.

## Where can you get help?

Free legal services are offered from the Centre's offices and visiting service locations, including:

- Head Office (Frankston)
- Bentleigh Branch
- Cranbourne Branch
- Rosebud Branch
- Visiting Services at Frankton North, Chelsea, and Hastings.
- Tenancy visiting services available in Pakenham, Narre Warren, Dandenong and St. Kilda.
- Duty lawyer service at Frankston Magistrates' Court (Family Violence Intervention Orders) available Monday-Wednesday
- Duty lawyer service at Federal Circuit Court of Australia (Dandenong Family Law Courts) Monday-Friday
- Duty advocate service (tenancy) at Victorian Civil and Administrative Tribunal in Dandenong, Moorabbin, Dromana and Frankston.

We offer telephone advice, day and evening appointments.

## Do you have special requirements?

We are committed to making our services accessible. If you have any special requirements, please let us know and we will try to help.

If you need an interpreter, we can organise a telephone or onsite interpreter for you.

You may bring a support person when attending the centre.
