Peninsula Community Legal Centre Inc. is an Incorporated Association. Any person who supports the Purpose of the Association is eligible to apply for membership.

- ◆ Application for membership is made by completing and submitting this form.
- ◆ Applications must be endorsed by two current members of the Association.
- ◆ Applications are considered by the Management Committee at the next scheduled meeting.
- ◆ The Management Committee will advise the applicant in writing of its decision.
- ◆ When a membership application is approved, the joining fee and annual membership fee become payable.
- ◆ The name, address and date of membership of the new member are entered in the Register of Members.
- ◆ The membership becomes effective from the date the Management Committee approves the application or the date on which the joining fee is paid, whichever is later.

Membership Entitlements

Current and financial members of Peninsula Community Legal Centre are entitled to:

- ◆ Receive notice of proposed general meetings of members.
- ◆ Submit items of business for consideration at a general meeting.
- ◆ Attend, participate in and vote at general meetings.
- ◆ Have access to minutes of general meetings and other documents.
- ◆ Inspect the Register of Members.
- ◆ Nominate for a position on the Committee of Management.
