## MEMBERSHIP APPLICATION AND APPROVAL PROCESS

Peninsula Community Legal Centre Inc. is an Incorporated Association. Any person who supports the Purpose of the Association is eligible to apply for membership.

- Application for membership is made by completing and submitting this form.
- Applications must be endorsed by two current members of the Association.
- Applications are considered by the Management Committee at the next scheduled meeting.
- The Management Committee will advise the applicant in writing of its decision.
- When a membership application is approved, the joining fee and annual membership fee become payable.
- The name, address and date of membership of the new member are entered in the Register of Members.
- The membership becomes effective from the date the Management Committee approves the application or the date on which the joining fee is paid, whichever is later.

## MEMBERSHIP ENTITLEMENTS

Current and financial members of Peninsula Community Legal Centre are entitled to:

- Receive notice of proposed general meetings of members.
- Submit items of business for consideration at a general meeting.

- Inspect the Register of Members.
- Nominate for a position on the Committee of Management.
